V. Transportation and Handling Fees

A quotation specifically tailored to your transportation needs and on-site handling requirements will then be prepared and faxed to you as soon as possible for your review.

Giveaways, printed matter, and / or goods to remain permanently in Mexico should be packed separately from goods being entered on a temporary basis.

The new requirements specify that wood packaging material be either heat treated or fumigated with methyl bromide and marked with an approved international logo, certifying that the wood packaging material has been appropriately treated. Wood packaging material imported without the international logo will be subject to re-exportation

VII. Documents Required for Clearance in Mexico

In order to arrange Mexican Customs clearance, we must have a completed Proforma Invoice and Packing List for your shipment. **All items, regardless of value or quantity, must have accurate piece counts listed on the Proforma Invoice and Packing List.** All goods will be inventoried by Rock-It Cargo personnel, either at the consolidation facility in Laredo, Texas, prior to crossing the border into Nuevo Laredo, or at the airport in Mexico City, or the port of arrival. This standard procedure is mandatory to ensure all goods that are packed in the crates are represented accurately on the Proforma Invoice and Packing List. If there is a discrepancy, an amended Proforma Invoice and Packing List will be generated, so that we may properly and lawfully generate the documentation for Mexican Customs clearance.

In addition to a Proforma Invoice and Packing List, a Certificate of Origin is required for all inbound shipments to Mexico. For U.S. and Canadian exhibitors, it is suggested that you utilize a NAFTA Certificate of Origin, if applicable to your goods.

Consumable items remaining in Mexico will be cleared on a permanent basis with the duties and/or taxes becoming the responsibility of the Exhibitor. Items intended for temporary use at the show can be cleared utilizing a temporary import entry that requires the shipment exit Mexico under customs supervision at the conclusion of the show.

We recommend items intended for Temporary Import be documented and packed separately from items intended for Permanent Import to facilitate the two different types of clearance required.

Failure to submit documents per our deadlines or provision of incomplete information such as DETAILED DESCRIPTIONS, piece counts, and values, can result in delays to your cargo's arrival at the PAACE exhibition. Rock-It Cargo will not be responsible for delays associated with the Mexican Customs Clearance process as a result of improper documentation submitted by exhibitors. All documents must be submitted for initial review PRIOR to freight's departure from Origin.

IX. Handling of Your Exhibit Material On-Site in Mexico City

In conjunction with our agent **Multi-Transportes Internacionales** in Mexico City, we will clear all exhibition material through Mexican Customs and deliver to the fairgrounds. Upon arrival, we will inventory and store the equipment until you would like for us to arrange delivery to your booth. We will do so coordinating all labor and equipment necessary, and provide you with labor and or equipment for unpacking, assembling and positioning, if necessary. Once your empty crates/cartons are ready to be removed from your booth, we will arrange to have them picked up and taken to the empty storage facility on-site. At the close of the show, we will arrange for the re-delivery of your empties, re-packing if necessary, arrange for the re-export of your exhibition material to any destination and prepare and complete all necessary export documentation, including cancellation of temporary import bonds. Our on site staff will be with you every step of the way, prior to, during and after the show.

X. Transportation and On-Site Insurance Coverage

While **ROCK-IT Cargo** always maintains the utmost care in handling your cargo, there are inherent risks involved in transportation that may cause losses beyond our control. As you may know, all companies in the logistics industry incorporate in their documents clauses limiting their liability in the event of loss or damage to cargo or consequential loss resulting from negligence, delay, etc. These limitations of liability are standard throughout the industry and are based on various treaties and approved by national transport associations

To effect cargo insurance on all of your future shipments handled by **ROCK-IT Cargo** simply complete our Cargo Insurance Request Form and return it to our office. We encourage you to take advantage of our cargo insurance program to ensure your goods are properly protected against the many perils of international transit. Even if you have your own cargo insurance policy, we may be able to provide you with broader coverage and more competitive rates.

XI. ROCK-IT Cargo Terms and Conditions

ROCK-IT Cargo will coordinate the entire shipping transaction. The exhibitor will receive one invoice covering all charges to delivered stand and one for the return, should the latter apply. Our invoices are payable upon presentation, but not later than the commencement of the show for the outbound cargo and prior to return of the cargo to the customer for return charges. In accordance with this shipping instruction, **ROCK-IT Cargo** arranges for shipping of exhibits from the designated locations to the booths at the exhibition site. However, the liability for loss or damage of material shipped under **ROCK-IT Cargo** direction, on behalf of its client is limited to the liability of the carriers and/or service contractors employed on the client's behalf, as stated in their tariff of conditions of operation.
